SFF Re-Fill Plus<sup>®</sup> a mixture of natural concentrated phytobiotic powder to be incorporated into animal feed.

Phytobiotics are pure substances extracted from plants in the form of powder, essential oils of herbs, leaves, roots or fruits, which act against pathogenic bacteria and which are added to the feed to improve zootechnical production parameters.

The emergence of antibiotic-resistant bacteria has created the need to replace antibiotics with other products such as prebiotics, probiotics, organic acid botanicals, and herbal essential oils.

Good intestinal health is very important from the birth of the animal to the end of its productive cycle, favoring the most efficient use of food and the expression of its productive genetic potential.

## RECOMMENDED DOSAGE

Mix SFF Re-Fill Plus ® at a dose of:  
In Aquaculture  
From 5 to 10 Kg per MT as a preventive  
From 30 to 50 Kg per TM as a healing.

In Poultry and pigs  
4 Kg per MT as a preventive  
8 -10 Kg per MT as a healing

A homogeneous mixture should be made.  
To be managed throughout the production cycle.  
It can be used in pelletized feed.
