DESCRIPTION

SFF Re-Fill Plus® is a mixture of natural concentrated phytobiotic powders to be incorporated into balanced feed for animal use, improving digestibility and survival. The product has immunostimulating, bacteriostatic and antiparasitic properties..

Phytobiotics are pure substances extracted from plants in the form of powder, essential oils from herbs, leaves, roots or fruits, which act against pathogenic bacteria and are added to balanced feed to improve zootechnical production parameters. The emergence of antibiotic resistant bacteria has created the need to replace antibiotics with other products such as prebiotics, organic acid botanicals, and herbal essential oils. Humic acids are natural chelators and toxin traps, essential oils confer antibacterial and antiparasitic properties, promote digestibility in the animal.
