DESCRIPTION

SFF Probiotic Pellets is a preparation of probiotics and prebiotics. They are golden pellets from 0.5 to 1.5mm. The product is pelletized which benefits the direct application for manual or automatic feeding. The product has a balanced mixture of Probiotics, its main function is to promote a beneficial flora that helps the animal's defense, feed digestibility and shrimp survival.

Shrimp in the postlarva stage 12 and up.

RECOMMENDED DOSE

Aquaculture:

Raceways and Nurseries

Use 4-10 grams of SFF Probiotic Pellets 0.5 mm per every Kg of feed.

Growth out

Use 0.1 to 0.25 g of SFF Probiotic Pellets 1.5 mm per every Kg of feed (up to 2.5 MT/ha)

Use 0.1 to 0.5 g of SFF Probiotic Pellets 1.5 mm per every Kg of feed (2.5- 5 MT/ha)

Use 0.5 to 1 g of SFF Probiotic Pellets 1.5 mm per every Kg of feed (>5 MT/ha)

Note: every gram of SFF probiotic Pellets per Kg of feed provides 40 millones of bacillus spores per gram.

INSTRUCTIONS FOR USE

Store and transport in ventilated, dry and pest-free places. Protect from the sun. Do not stow more than 5 stacked units. This product expires 12 months from its date of manufacture. The feeding program is only effective if proper management practices are followed.
